DESCRIPTION OF ASSET CLASSES

The Gradient Absolute Yield Portfolio seeks attractive opportunities across a diversified mix of securities to ensure high income and diversification. The portfolio will deliver a relatively high level of income for investors versus traditional fixed income solutions. These non-traditional assets provide a balanced approach to generating higher sources of income. The investor gains exposure to:

Dividend Paying Equities: Stocks of global corporations that pay high dividends.

Real Estate Investment Trusts (REITs): Entities that derive income from real estate transactions and rentals.

Mortgage REITs: Entities that derive income from investments in mortgages and mortgage debt.

Business Development Companies (BDCs): Entities that provide loans to smaller companies in their initial stages of development. BDCs are similar to venture capital funds.

Preferred Stocks: A hybrid security between common stock and debt in the corporate capital structure that pay dividends. Preferred dividends are paid before common stock dividends.

Master and Limited Partnerships (MLPs and LPs):

Natural resource-based (often energy) entities paying income streams from profits in developing, extracting, transporting and selling these resources.

High-Yield Bonds: Bonds rated below investment grade which typically have higher yields.

Emerging Market Bonds: Bonds that are originated in emerging market countries which tend to have lower credit ratings and higher yields due to increased economic and political risk.

Senior Bank Loans: Floating rate bank loans to non-investment grade companies which are collateralized by corporate assets. Coupon rates are reset to market interest rates at regular intervals.


